Rules & Regulations

Do's:

- ✓ **Be aware that you are responsible for your conduct at all times.**
- ✓ **Wear your name badge at all times. Badge must be visibly worn at all times.**
- ✓ **Attend all sessions and activities as per schedule.**
- ✓ **Know where your key and meal cards are at all times. There is a \$100.00 charge for lost keys/meal cards.**
- ✓ **Dress appropriately at all times.**
- ✓ **Be sure to limit all social activity to public areas only.**
- ✓ **All rules and regulations of Monmouth University MUST be followed.**

Don'ts:

- ✓ **Socializing in suites/quads/rooms with members of the opposite sex will not be allowed.**
- ✓ **Use of foul or abusive language will not be tolerated.**
- ✓ **Please do not make excessive noise while going to or returning from sessions and activities.**
- ✓ **There will be no smoking permitted in campus buildings. You must be 19 years of age to smoke in the state of New Jersey.**
- ✓ **There will be no illegal drugs, alcoholic beverages, weapons, fireworks or other related items. Anyone caught with these items is subject to New Jersey State Law and will be sent home immediately at their own expense.**
- ✓ **Anyone caught damaging University or Convo participant property will be sent home immediately and charged for repairs by the University or Convo 2010 Committee.**
- ✓ **Inappropriate dress (lewd and profane T-shirts, clothing that is too small, too tight, etc.) will not be permitted at Convo.**
- ✓ **No cell phones, iPods, electronic devices, etc will be allowed during Holy Mass or Convo sessions. Anyone caught using any electronic device will have that device confiscated.**
- ✓ **No one will be allowed to leave the campus under any circumstances.**

Violation of these rules and regulations will be handled by the Convo 2010 Tribunal.
